The Michigan Public Health Institute is offering a grant funding opportunity to Michigan programs with a focus on Alzheimer's Disease and related dementias. Grants should incorporate at least one of the following:

- Promote education about brain health, cognitive aging, and cognitive decline risk factors
- Promote education on Alzheimer's Disease and related dementias
- Promote education on early detection and diagnosis
- Promote education on effective care planning at all stages of dementia
- Promote engagement of care partners in care management strategies
- Promote strategies for optimizing health and well-being for those impacted by dementia and their caregivers

Background

The action items for this community-based grant funding opportunity were created to promote cognitive health, address cognitive impairment for those affected by dementia, and to meet the needs of care partners. For this funding opportunity, we are recognizing three actions from the list of 25 actions in the *Healthy Brain Initiative*, *State and Local Public Health Partnerships to Address Dementia 2018-2023 RoadMap*.

The three actions that were chosen from the RoadMap are:

E1 = Educate the public about brain health and cognitive aging, changes that should be discussed with a health professional, and benefits of early diagnosis.

E2 = Integrate the best available evidence about brain health and cognitive decline risk factors existing health communications that promote health and chronic condition management for people across the life span.

W4 = Foster continuing education to improve healthcare professionals' ability and willingness to support early diagnosis and disclosure of dementia, provide effective care planning at all stages of dementia, offer counseling and referral, and engage caregivers, as appropriate, in care management.

The objective of this funding opportunity is to use one or more of these action items to promote community-based education and support for those impacted by dementia. These actions can be tailored to best fit into the strengths and needs of your community. Please be creative with your funding request while using evidence-based data.

Mini Grant Ideas: Community Tailored and Creative

Put special consideration towards ideas that are creative, person-centered, and engaging. Special consideration will be given to ideas that include incorporation of socially minded, person-centered approaches.

Please refer to the Community Connect program through the Alzheimer's Association for ideas on creative programming that is already taking place. While we do not want to duplicate efforts, please use their events as a creative springboard for your own.

Examples:

- Host a class or series of classes
- Create a training
- Develop an educational outing for adults with dementia and their care partners
- Create an experiential event
- Connect with local community resources, the arts, music, performances
- Incorporate biophilic design or promote positive relationships of nature and brain health through community places such as local nature centers

Funding

There are three different funding ranges. Please select one depending on your community project and need.

A. \$5,000 - \$10,000

B. \$10,000 - \$15,000

C. \$15,000 - \$20,000

Approximately 10 grants will be awarded.

Eligibility

Eligible entities are those that are intending to develop or expand their initiatives related to cognition, Alzheimer's Disease, and/or related dementias.

Reporting Requirements

If awarded, an introductory call will be conducted to discuss proposal outcomes. A final report will be due to MPHI on September 30th, 2023. A template for reporting will be provided. All funding must be spent by September 30th, 2023.

Ineligibility

This grant will not award funding for personal care matters related to dementia care.

Deadlines and award dates

April 2023: Application released

May 25, 2023: Application due

June 1, 2023: Award selection announced

September 30, 2023: All award funding must be spent and final report due
